

## TAKE ACTION THROUGH LETTER WRITING CAMPAIGNS

On October 17<sup>th</sup>, the International Day for the Eradication of Poverty, the PMR GLI Working Group launched a letter writing campaign at both the municipal and provincial governance levels. The aim of this campaign is to demonstrate a critical mass of individuals, families and communities of faith, who advocate strongly for a GLI Program to be incorporated in anti-poverty strategies at the provincial/territorial and national levels of governance in Canada. Letter writing campaigns are most effective when followed up by visits to your representatives; ask for a meeting in your letter. Bring others with you, representatives from your Community of Faith or Justice Group, collaborate with other justice and anti-poverty advocacy groups in your community and ask them to join you.

### **Municipal Letter Writing Campaign:**

Write to your municipal government, mayor, and/or municipal councillors to ask them to advocate as a municipality to the provincial/territorial level for the implementation of a GLI Program. Municipal and City governments can write and pass a resolution as a way to commit to advocating for GLI on a regular basis. In your letter, request a meeting with your mayor and or councillors, ask that they put a GLI resolution on the agenda for an upcoming council meeting, and/or attend council meetings to encourage the mayor and/or councillors toward GLI advocacy. ### **Provincial/Territorial Letter Writing Campaign:**

As an individual, a committee or an entire Community of Faith, write a letter, an email, or make a phone call to the members of your Legislative Assembly advocating for the implementation of a Guaranteed Livable Income program in BC and/or Yukon. Ask your representatives for a meeting to discuss the importance of Anti-Poverty action and legislation in your community. Provincial and Territorial Governments have the jurisdictional ability to implement GLI programs and demonstration projects, as well as advocate to the federal level for the implementation of a National GLI Program.

You may also want to write a letter to the Provincial/Territorial Minister in charge of Social Development and Poverty Reduction. You may use Rev.
